

Client Account Opening Process by SAL Securities Pvt. Ltd.:

01: The new on boarding Client has to Submit duly filled client agreement books with all the required signatures and photographs in place.

02: The Client has to submit KRA and CKYC Number, Supporting documents with the duly filled client agreement book.

03: SAL Securities Pvt. Ltd's Office Executive will visit the clients correspondence address and will do the verification of documents submitted by the client. On verification the client documents, we will allot the UCC Code to the client and at the same very moment data is uploaded on UCC Portal of NSE and BSE (Both Exchange) The same UCC Number is allotted to the client in our Back office System.

04: After the generation of The UCC in NSE and BSE Portal and then in the Back office we allow the client to trade from the next day of generation of Unique Client Code.
